PDG outcomes

My Concern purchased. Ease of access for all bodies working with individuals identified as needing support. Children easily identified as a cause for concern and links to associated stakeholders easily accessed and information shared as required

Speech and Language Link subscription

Speech and Language Link identifies difficulties that children have and programmes of development help children overcome speech and language difficulties and achieve their potential across the curriculum

Attendance officer tracking attendance and letters sent to parents for attendance below 90% Attendance officer and headteacher worked closely with EWO and parents to increase attendance levels. Attendance levels for FSM children increased

TA working with identified children – providing reading, and Letters and Sounds support Children able to perform to their potential and achieving targets

Pastoral Care Manager working with families FSM families receiving support and signposted to services available. Workshops arranged with INREACH CAHMS officer –large take- up TA working with children on sensory circuits

Sensory circuits completed every morning for no more than 15-20 minutes. Children very receptive to the programme and are far more settled for their first lesson
